ARTICLES OF ASSOCIATION

(amended by Special Resolutions dated 26 May 2012, 1 June 2013, 13 June 2015, 18 June 2016, and 5 July 2025)

of

THE TWENTIETH CENTURY SOCIETY LIMITED

Interpretation

1 In these articles:

"the Act" means the Companies Act 1985;

"address" means a postal address or, for the purposes of electronic communication, a fax number, an e-mail address or a text message number in each case registered with the Society;

"the Society" means the company intended to be regulated by these articles;

"clear days" in relation to the period of a notice means a period excluding:

- the day when the notice is given or deemed to be given; and
- the day for which it is given or on which it is to take effect;

"the Commission" means the Charity Commissioners for England and Wales;

"the memorandum" means the memorandum of association of the Society;

"officers" includes the Directors and the secretary;

"the seal" means the common seal of the Society if it has one;

"secretary" means the secretary of the Society or any other person appointed to perform the duties of the secretary of the Society, including a joint, assistant or deputy secretary;

"the Directors" means the directors of the Society. The directors are charity trustees as defined by Section 97 of the Charities Act 1993;

"the United Kingdom" means Great Britain and Northern Ireland; and

words importing one gender shall include all genders, and the singular includes the plural and vice versa.

Unless the context otherwise requires words or expressions contained in these articles have the same meaning as in the Act but excluding any statutory modification not in force when this constitution becomes binding on the Society.

Apart from the exception mentioned in the previous paragraph a reference to an Act of Parliament includes any statutory modification or re-enactment of it for the time being in force.

Members

2

The Twentieth Century Society

- (1) The subscribers to the memorandum are the first members of the Society.
- (2) Membership is open to other individuals or organisations who:
 - (a) apply to the Society in the form required by the Directors, and
 - (b) are approved by the Directors.
- (3) The Directors-
 - (a) may only refuse an application for membership if, acting reasonably and properly, they consider it to be in the best interests of the Society to refuse the application;
 - (b) must inform the applicant in writing of the reasons for the refusal within twenty-one days of the decision;
 - (c) must consider any written representations the applicant may make about the decision. The Directors' decision following any written representations must be notified to the applicant in writing but shall be final.
- (4) Membership is not transferable to anyone else.
- (5) The Directors must keep a register of names and addresses of the members.

Classes of Membership

3

- (1) The Directors may establish classes of membership with different rights and obligations and shall record the rights and obligations in the register of members.
- (2) The Directors may not directly or indirectly alter the rights or obligations attached to a class of membership.
- (3) The rights attached to a class of membership may only be varied if:
 - (a) three-quarters of the members of that class consent in writing to the variation, or
 - (b) a special resolution is passed at a separate general meeting of the members of that class agreeing to the variation.
- (4) The provisions in these articles about general meetings shall apply to any meeting relating to the variation of the rights of any class of members.

Termination of Membership

4 Membership is terminated if:

- (1) the member dies or, if it is an organisation, ceases to exist;
- (2) the member resigns by written notice to the Society unless, after the resignation, there would be less than two members;
- (3) any sum due from the member to the Society is not paid in full within three months of it falling due;
- (4) the member is removed from membership by a resolution of the Directors that it is in the best interests of the Society that his or her membership is terminated. A resolution to remove a member from membership may only be passed if:

- (a) the member has been given at least twenty-one days' notice in writing of the meeting of the Directors at which the resolution will be proposed and the reasons why it is to be proposed;
- (b) the member or, at the option of the member, the member's representative (who need not be a member of the Society) has been allowed to make representations to the meeting.

Annual General Meetings

5

- (1) The Society must hold its first annual general meeting within eighteen months after the date of its incorporation.
- (2) An annual general meeting must be held in each subsequent year and not more than fifteen months may elapse between successive annual general meetings.
- (3) All general meetings other than annual general meetings shall be called extraordinary general meetings.

6

- (1) The Directors may call an extraordinary general meeting at any time.
- (2) The Directors shall call an extraordinary general meeting within 42 days of receiving a request for such a meeting-
 - (a) signed by at least 25 members of the Society, and
 - (b) specifying the issues to be addressed at the meeting.

Notice of general meetings

7

- (1) The minimum periods of notice required to hold a general meeting of the Society are:
 - (a) 21 clear days for an annual general meeting and an extraordinary general meeting called for the passing of a special resolution;
 - (b) 14 clear days for all other extraordinary general meetings.
- (2) A general meeting may be called by shorter notice if it is so agreed:
 - (a) in the case of an annual general meeting, by all the members entitled to attend and vote; and
 - (b) in the case of an extraordinary general meeting, by a majority in number of members having a right to attend and vote at the meeting who together hold not less than 95 percent of the total voting rights.
- (3) The notice must specify the date time and place of the meeting and the general nature of the business to be transacted. If the meeting is to be an annual general meeting, the notice must say so.
- (4) The notice must be given to all the members and to the Directors and auditors.

- 8 The proceedings at a meeting shall not be invalidated because a person who was entitled to receive notice of the meeting did not receive it because of an accidental omission by the Society.

Proceedings at general meetings

9

- (1) No business shall be transacted at any general meeting unless a quorum is present. 'Present' includes being present by suitable electronic means agreed by the Directors in which a participant or participants may communicate with all the other participants.
- (2) A quorum is 25 members entitled to vote upon the business to be conducted at the meeting.
- (3) The authorised representatives of a member organisation shall be counted in the quorum;
- (4) A general meeting may be held by suitable electronic means agreed by the Directors in which each participant may communicate with all the other participants.

10

- (1) If-
 - (a) a quorum is not present within half an hour from the time appointed for the meeting, or
 - (b) during a meeting a quorum ceases to be present,the meeting shall be adjourned to such time and place as the Directors shall determine.
- (2) The Directors must reconvene the meeting and must give at least seven clear days' notice of the reconvened meeting stating the date, time and place of the meeting.
- (3) If no quorum is present at the reconvened meeting with fifteen minutes of the time specified for the start of the meeting the members present at that time shall constitute the quorum for that meeting.

11

- (1) General meetings shall be chaired by the person who has been appointed to chair meetings of the Directors.
- (2) If there is no such person or he or she is not present within fifteen minutes of the time appointed for the meeting a Director nominated by the Directors shall chair the meeting.
- (3) If there is only one Director present and willing to act, he or she shall chair the meeting.
- (4) If no Director is present and willing to chair the meeting within fifteen minutes after the time appointed for holding it, the members present and entitled to vote must choose one of their number to chair the meeting.

12

- (1) The members present at a meeting may resolve by ordinary resolution that the meeting shall be adjourned.
- (2) The person who is chairing the meeting must decide the date time and place at which meeting is to be reconvened unless those details are specified in the resolution.
- (3) No business shall be conducted at a reconvened meeting unless it could properly have been conducted at the meeting had the adjournment not taken place.
- (4) If a meeting is adjourned by a resolution of the members for more than seven days, at least seven clear days' notice shall be given of the reconvened meeting stating the date time and place of the meeting.

13

- (1) Any vote at a meeting shall be decided by a show of hands unless before, or on the declaration of the result of, the show of hands a poll is demanded-

- (a) by the person chairing the meeting, or
 - (b) by at least two members having the right to vote at the meeting, or
 - (c) by a member or members representing not less than one-tenth of the total voting rights of all the members having the right to vote at the meeting.
- (2)
- (a) The declaration by the person who is chairing the meeting of the result of a vote shall be conclusive unless a poll is demanded.
 - (b) The result of the vote must be recorded in the minutes of the Society but the number or proportion of votes cast need not be recorded.
- (3)
- (a) A demand for a poll may be withdrawn, before the poll is taken, but only with the consent of the person who is chairing the meeting.
 - (b) If the demand for a poll is withdrawn the demand shall not invalidate the result of a show of hands declared before the demand was made.
- (4)
- (a) A poll must be taken as the person who is chairing the meeting directs, who may appoint scrutineers (who need not be members) and who may fix a time and place for declaring the results of the poll.
 - (b) The result of the poll shall be deemed to be the resolution of the meeting at which the poll is demanded.
- (5)
- (a) A poll demanded on the election of a person to chair a meeting or on a question of adjournment must be taken immediately.
 - (b) A poll demanded on any other question must be taken either immediately or at such time and place as the person who is chairing the meeting directs.
 - (c) The poll must be taken within thirty days after it has been demanded.
 - (d) If the poll is not taken immediately at least seven clear days' notice shall be given specifying the time and place at which the poll is to be taken.
 - (e) If a poll is demanded the meeting may continue to deal with any other business that may be conducted at the meeting.
- 14 If there is an equality of votes, whether on a show of hands or on a poll, the person who is chairing the meeting shall have a casting vote in addition to any other vote he or she may have.
- 15 A resolution in writing signed by each member (or in the case of a member that is an organisation, by its authorised representative) who would have been entitled to vote upon it had it been proposed at a general meeting shall be effective. It may comprise several copies each signed by or on behalf of one or more members.

Votes of members

16

- (1) Subject to Articles 3 and 14 and the next paragraph,
 - (a) every member who is an individual shall have one vote, and

- (b) every member which is an organisation shall have two votes.
- (2) No member shall be entitled to vote at any general meeting or at any adjourned meeting if he or she owes any money to the Society.
- 17 Any objection to the qualification of any voter must be raised at the meeting at which the vote is tendered and the decision of the person who is chairing the meeting shall be final.
- 18
- (1) Any organisation that is a member of the Society may nominate up to two persons to act as its representative or representatives at any meeting of the Society.
- (2) The organisation must give written notice to the Society of the name of a representative. A nominee shall not be entitled to represent the organisation at any meeting unless the notice has been received by the Society. A nominee may continue to represent the organisation until written notice to the contrary is received by the Society.
- (3) Any notice given to the Society will be conclusive evidence that a nominee is entitled to represent the organisation or that his or her authority has been revoked. The Society shall not be required to consider whether a nominee has been properly appointed by the organisation.

President

- 18A (1) The members may, by ordinary resolution:
- (a) elect as President of the Society a person who has been nominated by the Directors as a candidate for that post, and
- (b) specify the period for which the person is to hold that office.
- (2) A President-
- (a) shall be entitled to attend and speak at meetings of the Directors as if he were a Director,
- (b) shall not be entitled to vote at such meetings, and
- (b) shall have such other duties as may be agreed between him and the Directors.
- (3) A President shall continue to hold office until:
- (a) the expiration of the period specified under paragraph (1)(b),
- (b) he resigns by notice to the Society,
- (c) he is removed by the members by ordinary resolution, or
- (d) another President is elected under paragraph (1).

Directors

- 19
- (1) A Director must be an individual aged 18 years or older.
- (2) No one may be appointed a Director if he or she would be disqualified from acting under the provisions of Article 31.
- 20 The number of Directors shall be not less than 3 and (unless otherwise determined by ordinary resolution) shall not be more than 16.

- 21 The first Directors shall be those persons notified to Companies House as the first directors of the Society.
- 22 A Director may not appoint an alternate director or anyone to act on his or her behalf at meetings of the Directors.

Powers of Directors

- 23
 - (1) The Directors shall manage the business of the Society and may exercise all the powers of the Society unless they are subject to any restrictions imposed by the Act, the memorandum, these articles or any special resolution.
 - (2) No alteration of the memorandum or these articles or any special resolution shall have retrospective effect to invalidate any prior act of the Directors.
 - (3) Any meeting of Directors at which a quorum is present at the time the relevant decision is made may exercise all the powers exercisable by the Directors.

Retirement

- 24 At the first annual general meeting all the Directors must retire from office unless by the close of the meeting the members have failed to elect sufficient Directors to hold a quorate meeting of the Directors. At each subsequent election of Directors one-third of the Directors or, if their number is not three or a multiple of three, the number nearest to one third must retire from office. If there is only one Director he or she must retire.
- 25
 - (1) The Directors to retire by rotation shall be those who have been longest in office since their last appointment. If any Directors became or were appointed Directors on the same day those to retire shall (unless they otherwise agree among themselves) be determined by lot.
 - (2) If a Director is required to retire at an annual general meeting by a provision of these articles the retirement shall take effect upon the conclusion of the meeting.

The Appointment of Directors

- 26 The Society may by ordinary resolution:
 - (1) appoint a person who is willing to act to be a Director, and
 - (2) determine the rotation in which any additional Directors are to retire.
- 27 No person other than a Director retiring by rotation may be appointed a Director at any general meeting unless:
 - (1) he or she is recommended for re-election by the Directors, or
 - (2) not less than fourteen nor more than thirty-five clear days before the date of the meeting, the Society is given a notice that:
 - (a) is signed by two members entitled to vote at the meeting,
 - (b) states those two members' intention to propose the appointment of a person as a Director,
 - (c) contains the details that, if the person were to be appointed, the Society would have to file at Companies House, and

- (d) is signed by the person who is to be proposed to show his or her willingness to be appointed.
- 27A If there are more persons standing for appointment as Directors at a general meeting than there are vacancies amongst the Directors then-
- (e) a separate vote shall be held for each person, and
- (f) the vacancy or vacancies shall be filled by the person or persons who receive the most votes.
- 28 All members who are entitled to receive notice of a general meeting must be given not less than seven nor more than twenty-eight clear days' notice of any resolution to be put to the meeting to appoint a Director other than a Director who is to retire by rotation.
- 29
- (1) The Directors may appoint a person who is willing to act to be a Director.
- (2) A Director appointed by a resolution of the other Directors must retire at the next annual general meeting and must not be taken into account in determining the Directors who are to retire by rotation.
- 30 The Directors may not appoint a person to be a Director if the appointment would cause the number of Directors to exceed the maximum number specified in Article 20.

Disqualification and removal of Directors

- 31 A Director shall cease to hold office if he or she:
- (1) ceases to be a Director by virtue of any provision in the Act or is prohibited by law from being a director,
- (2) is disqualified from acting as a Trustee by virtue of section 72 of the Charities Act 1993 (or any statutory re-enactment or modification of that provision),
- (3) ceases to be a member of the Society,
- (4) becomes incapable by reason of mental disorder, illness or injury of managing and administering his or her own affairs,
- (5) resigns as a Director by notice to the Society (but only if at least two Directors will remain in office when the notice of resignation is to take effect), or
- (6) is absent without the permission of the Directors from all their meetings held within a period of nine consecutive months and the Directors resolve that his or her office be vacated.
- (7) commits any breach of the code of conduct, and the Directors resolve that the Director cease to hold office. A resolution to remove a Director may only be passed if:
- (a) the Director has been given at least twenty-one days' notice in writing of the meeting of the Directors at which the resolution will be proposed and the reasons why it is to be proposed;
- (b) the Director or, at the option of the member, the member's representative (who need not be a member of the Society) has been allowed to make representations to the meeting, and that the President of the Society appoint an independent person to be involved with the process.

Directors' remuneration

32 The Directors must not be paid any remuneration unless it is authorised under clause 5 of the memorandum.

Proceedings of Directors

33

- (1) The Directors may regulate their proceedings as they see fit, subject to the provisions of the Articles. Meetings may be held by suitable electronic means agreed by the Directors in which each participant may communicate with all the other participants.
- (2) Any Director may call a meeting of the Directors.
- (3) The secretary must call a meeting of the Directors if requested to do so by a Director.
- (4) Questions arising at a meeting shall be decided by a majority of votes.
- (5) In the case of an equality of votes, the person who chairs the meeting shall have a second or casting vote.

34

- (1) No decision may be made by a meeting of the Directors unless a quorum is present at the time the decision is purported to be made. 'Present' includes being present by suitable electronic means agreed by the Directors in which a participant or participants may communicate with all the other participants.
- (2) The quorum shall be two or the number nearest to one third of the total number of Directors, whichever is the greater or such larger number as may be decided from time to time by the Directors.
- (3) A Director shall not be counted in the quorum present when any decision is made about a matter upon which that Director is not entitled to vote.

35 If the number of Directors is less than the number fixed as the quorum, the continuing Directors or Director may act only for the purpose of filling vacancies or of calling a general meeting.

36

- (1) The Directors shall appoint a Director to chair their meetings and may at any time revoke such appointment.
- (2) If no-one has been appointed to chair meetings of the Directors or if the person appointed is unwilling to preside or is not present within ten minutes after the time appointed for the meeting, the Directors present may appoint one of their number to chair that meeting.
- (3) The person appointed to chair meetings of the Directors shall have no functions or powers except those conferred by these articles or delegated to him or her by the Directors.

37

- (1) A resolution in writing signed by all the Directors entitled to receive notice of a meeting of Directors or of a committee of Directors and to vote upon the resolution shall be as valid and effectual as if it had been passed at a meeting of the Directors or (as the case may be) a committee of Directors duly convened and held.
- (2) The resolution in writing may comprise several documents containing the text of the resolution in like form each signed by one or more Directors.

Delegation

38

- (1) The Directors may delegate any of their powers or functions to a committee of two or more members; and the terms of any delegation must be recorded in the minute book.
- (1A) Each committee to which powers or functions are delegated-
 - (a) may include members who are not Directors, but
 - (b) must include at least one Director.
- (2) The Directors may impose conditions when delegating, including the conditions that:
 - (a) the relevant powers are to be exercised exclusively by the committee to whom they delegate;
 - (b) no expenditure may be incurred on behalf of the Society except in accordance with a budget previously agreed with the Directors.
- (3) The Directors may revoke or alter a delegation.
- (4) All acts and proceedings of any committees must be fully and promptly reported to the Directors.

39 A Director must absent himself or herself from any discussions of the Directors in which it is possible that a conflict will arise between his or her duty to act solely in the interests of the Society and any personal interest (including but not limited to any personal financial interest).

40

- (1) Subject to paragraph 40(2), all acts done by a meeting of Directors, or of a committee of Directors, shall be valid notwithstanding the participation in any vote of a Director:
 - (a) who was disqualified from holding office;
 - (b) who had previously retired or who had been obliged by the constitution to vacate office;
 - (c) who was not entitled to vote on the matter, whether by reason of a conflict of interest or otherwise;

if without the vote of that Director and that Director being counted in the quorum the decision has been made by a majority of the Directors at a quorate meeting.

- (2) Paragraph 40(1) does not permit a Director to keep any benefit that may be conferred upon him or her by a resolution of the Directors or of a committee of Directors if, but for paragraph 40(1), the resolution would have been void, or if the Director has not complied with article 39.

Regional Groups

40A

- (1) Regional Groups may (with the prior approval of the Board of Trustees) be formed to further the objectives of the Society in particular areas and to perform the Society's work in those areas to the extent approved by the Board of Trustees.
- (2) The Board of Trustees will constitute a Regional Groups Committee to which it will delegate the co-ordination of, monitoring of and support for the activities and functioning of the Regional Groups.
- (3) The Board of Trustees can make bylaws for Regional Groups in accordance with Article 50 and shall have the power to dissolve such groups if it deems necessary in the light of non-observance of such bylaws.

Seal

- 41 If the Society has a seal it must only be used by the authority of the Directors or of a committee of Directors authorised by the Directors. The Directors may determine who shall sign any instrument to which the seal is affixed and unless otherwise so determined it shall be signed by a Director and by the secretary or by a second Director.

Minutes

- 42 The Directors must keep minutes of all:
- (1) appointments of officers made by the Directors;
 - (2) proceedings at meetings of the Society;
 - (3) meetings of the Directors and committees of Directors including:
 - (a) the names of the Directors present at the meeting;
 - (b) the decisions made at the meetings; and
 - (c) where appropriate the reasons for the decisions.

Accounts

- 43
- (1) The Directors must prepare for each financial year accounts as required by section 226 (or, if applicable, section 227) of the Act. The accounts must be prepared to show a true and fair view and follow accounting standards issued or adopted by the Accounting Standards Board or its successors and adhere to the recommendations of applicable Statements of Recommended Practice.
 - (2) The Directors must keep accounting records as required by sections 221 and 222 of the Act.

Annual Report and Return and Register of Charities

- 44
- (1) The Directors must comply with the requirements of the Charities Act 1993 with regard to:
 - (a) the transmission of the statements of account to the Society;
 - (b) the preparation of an annual report and its transmission to the Commission;
 - (c) the preparation of an annual return and its transmission to the Commission.
 - (2) The Directors must notify the Commission promptly of any changes to the Society's entry on the Central Register of Charities.
- 45 Any notice to be given to or by any person pursuant to the articles:
- (1) must be in writing; or
 - (2) must be given using electronic communications.

- 46
- (1) The Society may give any notice to a member either:
 - (a) personally; or

- (b) by sending it by post in a prepaid envelope addressed to the member at his or her address;
or
 - (c) by leaving it at the address of the member; or
 - (d) by giving it using electronic communications to the member's address.
- (2) A member who does not register an address with the Society or who registers only a postal address that is not within the United Kingdom shall not be entitled to receive any notice from the Society.
- 47 A member present in person at any meeting of the Society shall be deemed to have received notice of the meeting and of the purposes for which it was called.
- 48
- (1) Proof that an envelope containing a notice was properly addressed, prepaid and posted shall be conclusive evidence that the notice was given.
 - (2) Proof that a notice contained in an electronic communication was sent in accordance with guidance issued by the Institute of Chartered Secretaries and Administrators shall be conclusive evidence that the notice was given.
 - (3) A notice shall be deemed to be given:
 - (a) 48 hours after the envelope containing it was posted; or
 - (b) in the case of an electronic communication, 48 hours after it was sent.

Indemnity

- 49 The Society shall indemnify every Director or other officer or auditor of the Society against any liability incurred by him or her in that capacity in defending any proceedings, whether civil or criminal, in which judgement is given in favour of the Director or in which the Director is acquitted or in connection with any application in which relief is granted to the Director by the court from liability for negligence, default, breach of duty or breach of trust in relation to the affairs of the Society.

Rules

- 50
- (1) The Directors may from time to time make such reasonable and proper rules as they may deem necessary or expedient for the proper conduct and management of the Society.
 - (2) The rules may regulate the following matters but are not restricted to them:
 - (a) the admission of members of the Society (including the admission of organisations to membership) and the rights and privileges of such members, and the entrance fees, subscriptions and other fees or payments to be made by members;
 - (b) the conduct of members of the Society in relation to one another, and to the Society's employees and volunteers;
 - (c) the setting aside of the whole or any part or parts of the Society's premises at any particular time or times or for any particular purpose or purposes;
 - (d) the procedure at general meetings and meetings of the Directors in so far as such procedure is not regulated by the Act or by these Articles;
 - (e) generally, all such matters as are commonly the subject matter of company rules.

The Twentieth Century Society

- (3) The Society in general meeting has the power to alter, add to or repeal the rules.
- (4) The Directors must adopt such means as they think sufficient to bring the rules to the notice of members of the Society.
- (5) The rules shall be binding on all members of the Society. No rule shall be inconsistent with, or shall affect or repeal anything contained in, the memorandum or the articles.
