Privacy Policy - P12

Adopted by the Trustees of The Twentieth Century Society on 20 March 2018

We value highly your contribution to our work. If you have joined the Society, or attended a C20 event, made a donation, bought a publication or asked to receive our non-members enewsletter, we may hold certain types of information about you. Our Privacy Policy gives you information about when, why and how we collect and use your data, and how we keep it secure. You can also change the information we hold, such as your preference for how we contact you.

We will make every effort to protect your data and make it accessible to you.

The information we hold helps us to provide services to members - such as mailing our magazine, letting you know about events and other news – and services related to events you have booked to attend. It also helps us keep track of things like how long you have been a member, what events you have attended etc. Together these records make sure we can manage your membership professionally and deliver your member benefits and other services and improve our services in the future.

About us

The Twentieth Century Society is a company limited by guarantee, registered in England no 05330664, registered office 70 Cowcross Street, London EC1M 6EJ, registered charity no 1110244. The Operations Manager of the company is the data controller of your personal information. What information we collect

We collect your information when you contact us or respond to communication from us. For example, when you become a member, book a place on an event, buy a publication or make a donation, whether by via our website, by email, post or on the telephone. We may vary the information we hold on you, if, for example, you notify us of a change of address. Non-members may choose to sign-up to receive our non-members e-newsletter or follow us on social media.

We collect data such as prefix (e.g. Mr, Ms or Mrs), name, address, email address, phone number, age ranges and data you may have provided specific to the service you have requested, e.g. dietary requirements for certain events.

We may add information that is publically available. This might be something that appears in the media or in public records.

We will occasionally cleanse our data files, to update them or make corrections, as information becomes available.

In addition, if you follow us on Facebook, Twitter, Instagram, Flickr or any other social media and messaging services, then you may be allowing us access to information from your accounts on those services. To manage what information might be accessible to us you can adjust your settings and privacy policies on each platform.

Why we collect your information and how we use it

We collect the information described above: to provide you with the services you have requested – e.g. to manage your membership or event booking. We will also use the information to let you know about other things the Society provides or does, for example, events, publications, campaigns.

Examples of how we use your data:

- To process new memberships and renewals
- To process event bookings and administration
- To notify you of a change to a service you have booked e.g. if the details of an event change
- To process publication purchases
- To contact you with information about the service you have requested from us eg event confirmation and joining details, renewal reminders, non-members e-newsletter or if we need other information from you, for example in relation to an event
- To help us in the administration of the Society and to provide services both to our members and to other people who engage with us
- To process donations
- To provide you with updates about events and news or ways to support our work and marketing activities.

We will also use the information to let you know about other things the Society provides or does, for example, events, publications, campaigns. We might also contact you if we need other information from you, or to notify you of a change to a service you have booked – e.g. if the details of an event change.

Marketing and other organisations

We will not share your data with any other organisations for marketing purposes unless we have your consent.

We may contact you to let you know about things related to our period or heritage conservation that might be of interest to you, including requests to support fundraising.

We will share your information with organisations who provide some of the services we offer – for example, the bank that processes our financial transactions with you and the company that manages our secure database. The organisations that provide these services meet high data security standards and will not use your data for anything other than the clear purposes of the service they are providing.

We are not responsible for the privacy protocols of other websites, even if you access them via links from our communications. We strongly suggest that you check the policy of each website you visit.

We work with our suppliers and make strenuous efforts to keep your information secure, but since no data transmission over the internet is 100% secure, please note that you provide the information at your own risk.

Storing and Protecting Your Data

We are committed to protecting the personal information you share with us. We have robust technology and processes in place to ensure your information is protected from unauthorized access and improper use. Our service providers are also required to have robust security in place.

We will keep your data only for as long as is reasonable. We may therefore ask you to give or renew your consent from time to time.

If you ask us to stop sending marketing communications to you, we will keep the minimum amount of information (e.g. name, address or email address) to ensure we fulfil your request.
